The Commission on Human Rights, established by the Economic and Social Council in 1946, was the first international body to deal with human rights. It was replaced in 1993 by the Human Rights Commission, which was in turn replaced by the Human Rights Council in 2006. The Council is the main human rights body of the United Nations.

The Council has 43 member states, elected by the General Assembly of the United Nations. It is responsible for promoting and protecting human rights, and for investigating and reporting on human rights violations. It also has the authority to recommend measures to be taken to address such violations.
