# CONSTITUTION OF THE UNIVERSITY OF SOUTHERN CALIFORNIA

Article I. Name and Location  
 Article II. Purpose and Mission  
 Article III. Organization and Structure

Section 1. The University shall have the honor and credit of the State of California. It shall be a public institution of higher learning and shall be free from sectarian influences.

Section 2. The University shall be organized as a corporation under the laws of the State of California. The Board of Regents shall be the governing body of the University. The Board of Regents shall consist of not more than nine members, one of whom shall be the Governor of the State, and the remainder shall be appointed by the State Legislature.

Section 3. The Board of Regents shall have the power to: (a) determine the location of the University; (b) determine the purposes and the general policy of the University; (c) determine the number, names, and locations of the colleges, divisions, and departments of the University; (d) determine the standards of admission to the University; (e) determine the standards of graduation from the University; (f) determine the standards of tenure and promotion of the faculty; (g) determine the standards of the student body; (h) determine the standards of the administration; (i) determine the standards of the library; (j) determine the standards of the student activities; (k) determine the standards of the alumni; (l) determine the standards of the external relations; (m) determine the standards of the financial affairs; (n) determine the standards of the physical plant; (o) determine the standards of the general administration.

## Article IV. Faculty and Administration

Section 1. The faculty of the University shall be the primary instrumentality for the promotion of the highest quality of scholarship and research and for the advancement of the general welfare of the State.

Section 2. The faculty shall have the right to elect the President of the University. The President shall have the honor and credit of the University and shall be the chief executive officer of the University. The President shall be elected for a term of not more than five years and shall be eligible for re-election for one additional term.

Section 3. The President shall have the power to appoint and remove the Vice Presidents of the University and the members of the Executive Council.
