

# 關於「中華民國」與「中華人民共和國」之區別

「中華民國」與「中華人民共和國」之區別，在於其政治體制、歷史淵源及國際地位之不同。中華民國為一民主共和國，其政體基於憲法，強調法治與人權保障。中華人民共和國則為一社會主義國家，其政體基於馬列主義，強調黨性與集體主義。
