# INTERNATIONAL CONFERENCE ON THE PROTECTION OF PERSONS UNDER SPECIAL ADMINISTRATIVE PROTECTION

The Conference was convened by the Secretary-General of the United Nations in accordance with the request of the General Assembly in its resolution 1753 (XVI) of 18 December 1961.
