第一章 總則
第一條 本會定名為「中華民國某某協會」。
第二條 本會之宗旨為：(一) 維護會員權益；(二) 促進會員福利；(三) 加強會員聯繫；(四) 服務社會大眾。
第三條 本會之組織由會員大會、理事會、監事會及秘書處等組成。

第四條 本會之經費來源包括：(一) 會員會費；(二) 社會捐助；(三) 政府補助；(四) 其他合法收入。

第五條 本會之辦事處設於某某市某某路某某號。如有需要，得在各地設立分會或辦事處。

第六條 本會之會員分為：(一) 正式會員；(二) 贊助會員；(三) 榮譽會員。凡我同胞，均可申請加入。

第七條 本會之會員大會為最高權力機關，由全體會員組成。每年召開一次，必要時得召開臨時大會。

第八條 本會之理事會由會員大會選舉產生，負責執行會員大會之決議。監事會則負責監督理事會之運作。
